

## **MASTERCLASS APM REGULATION**

### **1. Recipients**

The Masterclass are open to instrumentalists and singers of all nationalities.

### **2. Requirements**

About admission to instrumental courses is not required any specific title, but teachers can request a curriculum of completed studies.

Those who do not will be among the participating students may enroll as auditors: by sending the registration fee and will be taken into consideration if there were defections among the participating students.

### **3. Application and deadlines**

Candidates are required to send the application form by delivery letter with advice of delivery, fax or e-mail (*look at the references below*). The timing of delivery are indicated on the site [www.masteclassapm.com](http://www.masteclassapm.com), in the single Masterclass.

Applications received after the stated deadline will be considered, however, depending on the availability of actual places.

### **4. Participation fees**

The registration fee is € 80,00 (€ 50,00 for short courses), refundable only if the masterclass will be not activated, payable and send attachments to the application for participation in courses on bank account to Fondazione Scuola di Alto Perfezionamento Musicale - Bank Credito Cooperativo di Benevagienna (Saluzzo)

Single masterclass fees are indicated on web.

In the reason for payment must be given name and surname of the candidate and the indication of the Master of instrument you want to attend.

Each course will be terminated with a final concert, with the best students.

## **6. Certificates**

At the end of the Masterclass students who have successfully attended the course will receive a certificate stating the frequency of the Masterclass which took part.
